





Neighbourhood mediation: 8 volunteers



Training (basic training in neighborhood mediation and annual training) Intervisions

Skills: communicative, neutral, solutionoriented, active listening, discretion, ... Volunteers do the mediation alone



Theft prevention advise:7 volunteers



Only by volunteers (not longer by operational staff)
Theft prevention advise
Home visits and recontacting victims of burglaries
Infosessions at the request of associations like BIN
Pro-active on BIN start events




